#### **EXCELLENCE IN EDUCATION**

- FY22 Grand has been approved, and Perkins Phase 1 purchasing is underway.
- We will need to do another Comprehensive Local Needs Assessment (CLNA) which will include
  the districts Local Needs Assessment (LNA) and Program Data Reviews (PDR) for FY22.
- Performance Indicator data has been released and distributed to each district; PI data results
  must be published by the district. Any districts not meeting targets will be required to submit an
  Improvement Plan in January.
- Measurement Inc. has been hired by the State of Illinois to review how EFE's deliver funds and services. There will be surveys, and questionnaires sent out by the company and Margie has asked the districts to be prompt in returning those forms back to the state.

Margie reviewed the System Director Goals for the year.

c.

 Margie reviewed fund allocations to the districts, the FY22 Carl Perkins Grant allocation to CEANCI will be \$726,000 and the CTEI Grant allocation will be \$664,000.

- Enrollment in CEP is down this year, although we do expect it to rise again for FY23.
- Billing for FY22 CEP will be invoiced and sent to districts shortly.
