#### SYSTEM DIRECTOR'S REPORT

Ms. Dougherty discussed the final funds for FY23, all money's will be encumbered by August 31, 2023. The FY24 grant was approved in July with the targeted industries Manufacturing, Health Science, Transportation, and Education and the emerging industries Leisure & Hospitality and Information Technology.

CEANCI must submit a complete Quality Program of Study to ISBE by October 1. ISBE is requiring another CLNA to be completed by each EFE, the LNA will be available for each district in IWAS on October 15, this must be completed by March 1, and CEANCI must have the CLNA completed by April 30, 2024 ISBE is developing a new funding formula for the CTEI Grant. There will be no change in the funding formula used by the Perkins Grant.

There will be three System Technical Assistant Visits in FY24, Byron High School, Rockford East High School, and Guilford High School.
